Memorandum Handedover

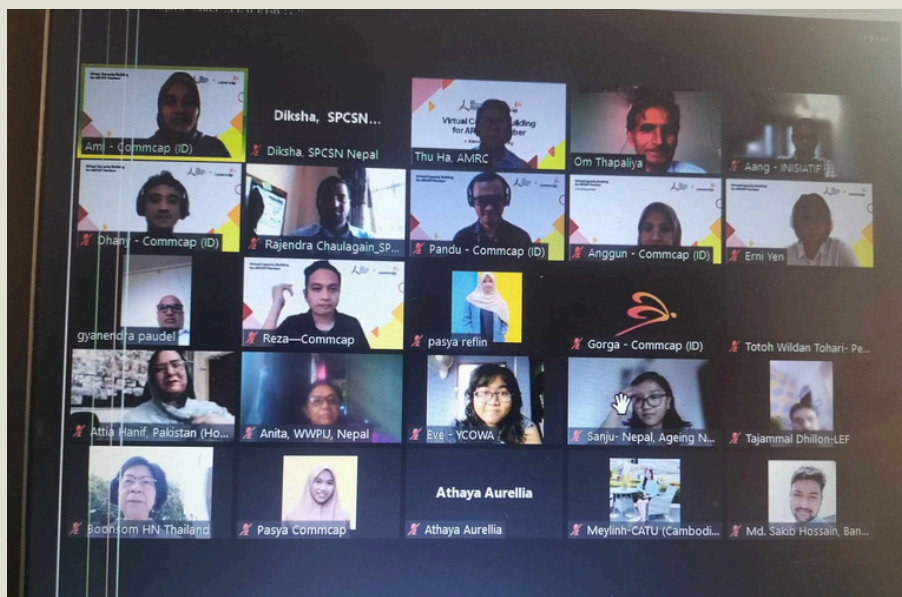

The memorandum demanded that the Child-Friendly Local Governance campaign be elevated to a national pride project. The CSOs also urged that the country be made child-friendly by 2087. By submitting the memorandum, the forum aimed to draw Minister Gupta's attention to the necessity of achieving this goal by the specified year.
