Asia Global Pathfinders 2nd Meeting in Nepal



On 10th September 2024, SPCSN coordinated and participated in the second Asia Global Pathfinders meeting, organized by We Social Movement (WSM) in Kathmandu. The Global Accelerator on Jobs and Social Protection for Just Transitions, launched in September 2021 by the UN Secretary-General, aims to bring together member states, international financial institutions, social partners, civil society, and the private

sector to support countries in creating 400 million decent jobs. The proposed strategy aims to create jobs in the green, digital, and care economies, while also extending social protection coverage to the 4 billion people currently excluded. It builds upon the priorities outlined in the UN Secretary-General's report "Our Common Agenda", as well as related roadmaps on social protection, the care economy and health workers, informality, jobs, just transitions (including green and digital), youth, and financing. The meeting brought together over 40 participants from seven countries, where experts presented the country-specific status of the Global Accelerator in Pathfinders' countries.

5 Days Training on Shock Responsive Social Protection

From 25th to 29th September 2024, the Social Protection Civil Society Network (SPCSN) organized a 5-day Master Training of Trainers (M-ToT) on Shock Responsive Social Protection (SRSP) in collaboration with INSP!R Nepal and with financial support from We Social Movement. The training was chaired by Tilottam Paudel, Chairperson of SPCSN, and emphasized the importance of integrating social protection with disaster risk management to improve preparedness and response to disasters in Nepal.

The first day included four key sessions: an overview of disaster management in Nepal, covering prevalent disasters and their frequency. The first day included four key sessions: an overview of existing management structures and challenges in disaster management; a review of the historical development of social security in Nepal, highlighting key milestones and legislative frameworks; an introduction to the newly developed Integrated National Social Security Framework, 2080, which outlined its components, objectives, and alignment with broader social protection goals; and an exploration of the relationship between social security and disaster management, emphasizing how social protection schemes can enhance disaster resilience and response.
