## Meeting with Ministry of Women, Children and Senior Citizens on Disability App

On 29th December 2024, an important meeting was held at the Ministry of Women, Children, and Senior Citizens (MOWCSC) meeting hall to discuss the endorsement of the Disability Management Information System (DMIS) application. This meeting, organized by the Social Protection Civil Society Network (SPCSN), was attended by key stakeholders, including



representatives from MOWCSC, UNICEF, Save the Children, CWISH, Ability Manch, and other civil society organizations. The primary objective of the meeting was to introduce and advocate for the DMIS application, which aims to facilitate disability screening, improve data-driven decisions, and promote disability rights in Nepal.

Policy Dialogue on Contribution Based Social protection



On 16th December,2024 Policy Dialogue on Contributory Social Protection has been successfully organized by INSP!R Nepal in collaboration with WSM, ITUC-NAC, and SPCSN. The significant event focusing on contributory-based social protection was chaired by Mr. Tilottam Paudel, Chairperson of SPCSN, and facilitated by the Social Security Fund (SSF). The program featured key insights from Mr. Laxman Sharma

of GFONT and Mr. Dinesh Sharma of SSF, who highlighted the important role of various stakeholders in the social protection system, particularly focusing on the challenges faced in engaging with the Social Security Fund (SSF). The dialogue also explored the potential contributions of Civil Society Organizations (CSOs) and trade unions in promoting inclusive social protection systems. The dialogue brought together 35 participants, including representatives from trade unions and CSOs. Among the participants, 20 were male, and 15 were female, reflecting a diverse and engaged participants.

On December 25, 2024, SPCSN had a board Meeting with the participation of 12 member among them 5 were female and 7 were male. The meeting was focused on the regular update and way forward and planning for 2025.
