# January to April Highlight, 2025

### T.V PROGRAM



Episode two of the television show was focused on "Child-Friendly Local Government (CFLG) and Protection" and was broadcast on 7 February 2024. Honorable Sita Rana, Member of Parliament, Resham Kandel, Under Secretary, MOFAGA, and Tilottam Paudel, Chairperson, SPCSN were the subject experts and panelists for this program. In this discussion session, the speakers highlighted that CFLG and social security should be integrated as complementary to each other. They also highlighted the need to ensure the participation and leadership of children in social security programs related to children. Due to the effectiveness of CFLG, they stressed the importance of continuing it. Furthermore, as the government has prioritized children's participation and leadership, they urged the need to make necessary improvements in policies and laws related to this.

# **ORIENTATION ON SRSP**



On 29th April, the Social Protection Civil Society Network (SPCSN), in coordination with Save the Children and in collaboration with the National Disaster Risk Reduction and Management Authority (NDRRMA), organized an orientation program on Shock Responsive Social Protection and the Relief Distribution Standard, 2081. The event was attended by 38 representatives from SPCSN's member organizations, who were the primary target audience. The orientation featured two key facilitators: Ms. Gomadevi Chamjong from NDRRMA and Mr. Nabin Shrestha from People in Need. Ms. Chamjong delivered a session on the concept of Shock Responsive Social Protection, outlining the objectives and foundational principles of the 2081 Standard. Mr. Shrestha focused on Disaster Risk Finance (DRF), highlighting its relevance and application within the broader framework of shockresponsive approaches.

### DIALOGUE ON SOCIAL PROTECTION



Between May 1st and 29th, 2025, SPCSN conducted Social Protection Dialogue Series aired five impactful episodes on Kantipur Television with partnership of World Bank Group (WBG), engaging key stakeholders to advance Nepal's social protection system. Topics covered included the need for a unified, beneficiary-focused framework with NPC-led reforms; integrated local-level data management for adaptive protection; strategic, contribution-based policies targeting vulnerable groups; decentralization and skills integration in the Prime Minister Employment Program; and coordinated, inclusive Shock Responsive Social Protection for disaster resilience. The series, also streamed on Facebook and YouTube, highlighted the urgent call for reform and collaboration toward an equitable, sustainable social protection system in Nepal.

### **CONFERENCE ON HUMAN RIGHTS DEFENDERS**

SPCSN led a policy dialogue on the theme "Gender Equality and Inclusion: Empowering Women Leaders for Sustainable Development and Peacebuilding" as part of a national conference on Human Rights Defenders held in Kathmandu from 5-6 March 2025. The event, organized under the leadership of the National Human Rights Council and supported by various development partners, brought together diverse voices to emphasize the critical role of women leaders in promoting inclusive development, safeguarding human rights, and fostering lasting peace in Nepal.

#### MEETING OF CHILD BUDGET CODE WORKING COMMITTEE

On 10th Feb, Ministry of Women, Children and Senior Citizens organized a meeting on child budget code working committee in Kathmandu where SPCSN Participated in the meeting as invitee member. The meeting was focused on developing detail work plan along with team formation for guideline for Child Budget code indorsement.

#### COORDINATION MEETING TO INTEGRATE DMIS INTO SIMS

Since its establishment, the Social Protection Civil Society Network (SPCSN) has been consistently advocating for comprehensive social protection. Among its key advocacy agendas, promoting disability rights and the use of technology in the disability sector has become a major focus. To advance this cause, SPCSN is providing technical support to 32 local governments across Sudurpaschim, Madhes, and Karnali Provinces to adopt the Disability Management Information System (DMIS) application under the EWPN program, in partnership with UNICEF and in collaboration with NEEDS. Currently, SPCSN is also working with CWISH as a technical partner on this specific initiative. In parallel, we are intensively advocating for the integration of the DMIS application into the Nepal Government's official Social Information Management System (SIMS). The Ministry of Women, Children, and Senior Citizens (MoWCSC) has agreed to support this integration. To accelerate this process, SPCSN has participated in coordination meetings with Save the Children and CWISH dated on On 24th February, forming a joint effort to move this agenda forward.

## LEARNING SHARING MEETING WITH MEMBER ORGANIZATIONS



On February 27th, SPCSN organized a Learning, Sharing, and Review Meeting on the localization of Shock Responsive Social Protection (SRSP) and the impact of the USAID funding project on member organizations. The meeting brought together 31 participants from SPCSN's member organizations. The session served as a dynamic platform to share key learnings, highlight achievements, and discuss the effects of the ongoing USAID funding crisis. Participants also provided valuable ground-level feedback based on their experiences. Additionally, the meeting included a review of accomplishments from 2024 and a discussion on the Advocacy Plan for 2025, reinforcing our shared commitment to building a more responsive and inclusive social protection system.
